### 5.1. Extinguishing media

### 6.1. Personal precautions, protective equipment and emergency procedures

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed. Keep away from sources of ignition. Prevent the build up of electrostatic charge in the immediate area. Ensure lighting and electrical equipment are not a source of ignition. Product is hygroscopic. Take precautions to avoid contact with atmospheric moisture. Store under Argon. Recommended storage temp 2-8 °C.
