## Section 4. First Aid Measures

- Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing. Get immediate medical attention.
- Skin Contact:** Wash off contaminated skin with soap and plenty of water. Get immediate medical attention.
- Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Call a POISON CENTER or doctor/physician immediately.
- Ingestion:** Call a physician or POISON CONTROL CENTER immediately. Rinse mouth. Do NOT induce vomiting. Remove dentures if any. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. ### Section 6. Accidental Release Measures

**Large Spill:**

Contain and collect spillage with non-combustible, dry absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in dry container for disposal according to local regulations (see Section 13). **Engineering Controls:**

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

**Environmental Exposure Controls:**

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. **Individual Protection Measures****Hygiene Measures:**
